- There is little agreement upon “an adequate university approach”

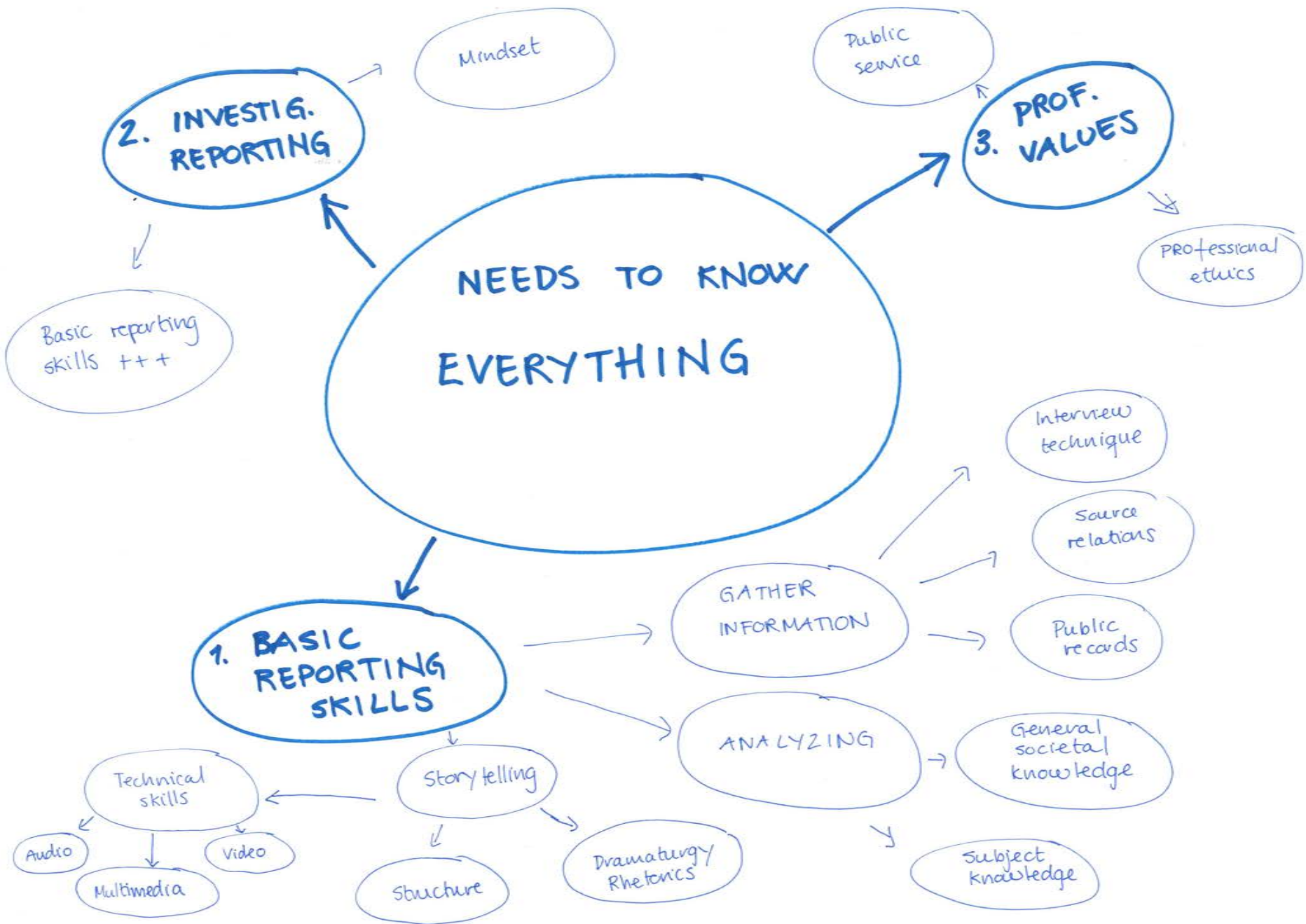

THREE MAIN QUESTIONS

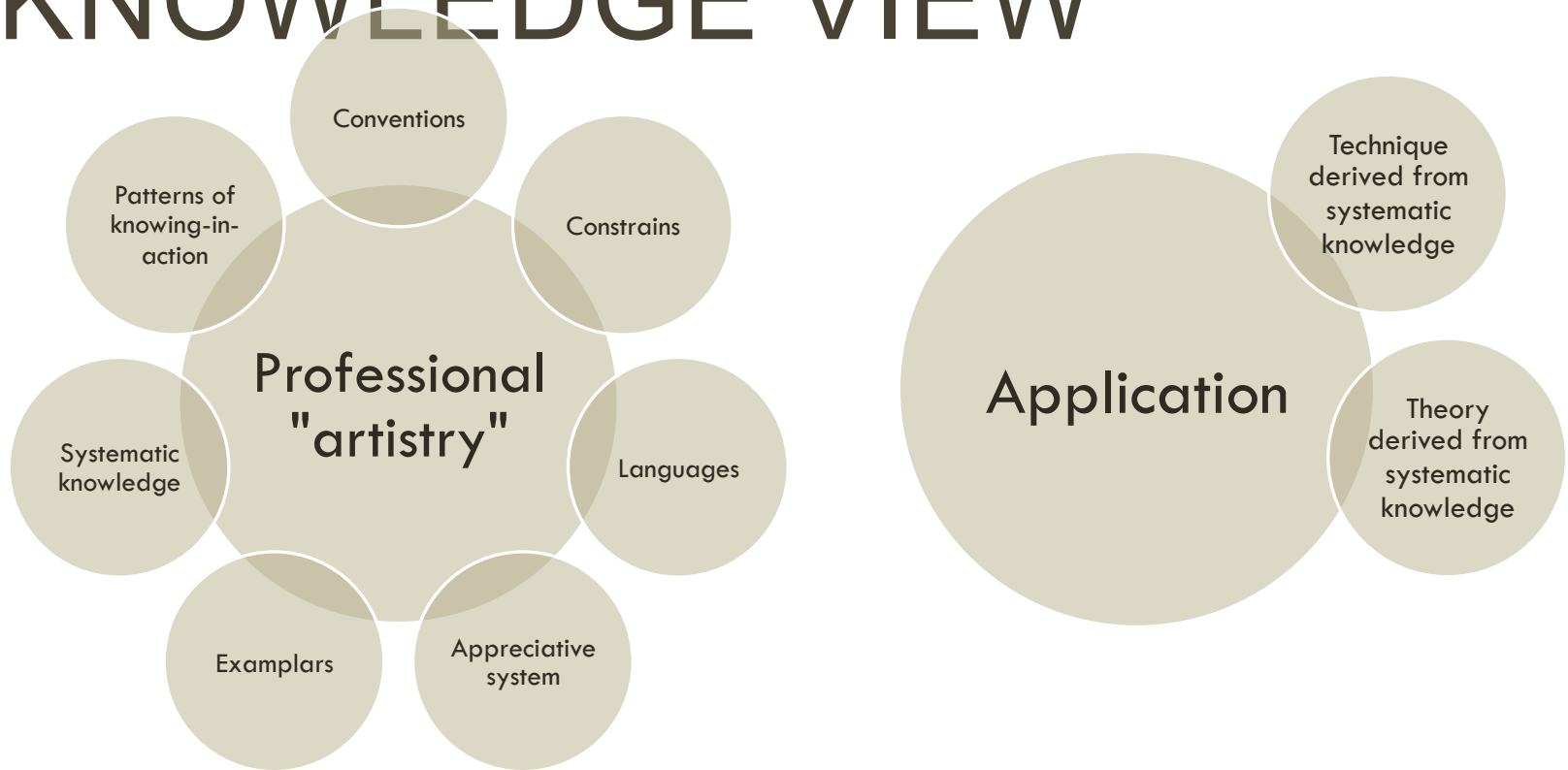
- What characterizes the journalistic knowledge base?

ITS COMPLICATED ...

Because the unique case falls outside the categories of existing theory and technique, the practitioner cannot treat it as an instrumental problem to be solved applying one of the rules in her store of professional knowledge. The case is not “in the book”. If she is to deal with it completely, she must do so by a kind of improvisation, inventing and testing in the situation strategies of her own devising

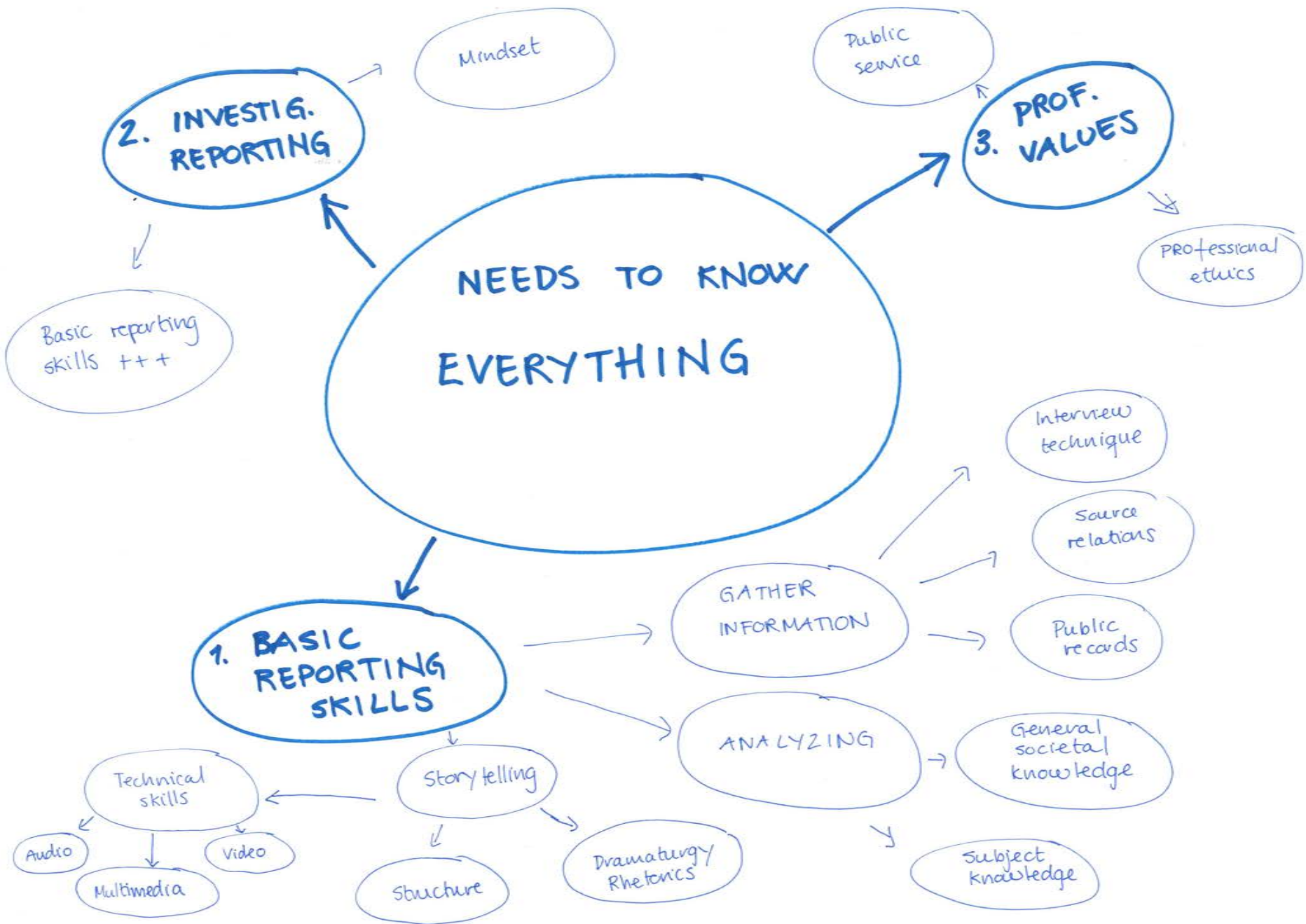
THE ROLE PERCEPTION OF U.S. REPORTERS

2014:

U.S. journalists are less likely to consider reaching the widest possible audiences and getting information to the public quickly as very important roles

U.S. journalists are more likely to emphasize the importance of investigating government claims and analyzing complex problems
